

# Lover's Rock Competition Terms and Conditions

Date: 06 February 2026

## 1. General Competition Information

- **Competition Name:** Lover's Rock Toyota Competition
- **Organiser:** Toyota South Africa Motors (Pty) Ltd ("Toyota"), Company registration number: 19961/001767/07, Stand 1, Wesco Park, Old Pretoria Main Road, Sandton, 2146, and its agencies ("Organiser").
- **Agreement to Terms:** By entering the Competition, all participants and winners agree to be bound by these rules, which will be interpreted by Toyota. Toyota's decision regarding any dispute will be final and binding. No further correspondence will be entered into regarding such decisions.
- **Right to Amend:** Toyota reserves the right to amend, modify, change, postpone, suspend, or cancel the Competition or any part thereof, without notice, for any reason Toyota deems necessary in its sole discretion.

## 2. Eligibility and Competition Area

- The Competition is open to all **permanent residents and citizens of South Africa** aged **18 years or older**, who hold a valid South African Identity Document or a valid Passport with the necessary endorsed residence permit.
- The following persons are not eligible to enter the Competition:
  - Individuals under 18 years of age.
  - Any employee, director, member, partner, agent, or consultant of Toyota or its agencies.
  - Immediate family members of any of the disqualified persons listed above.
- The Competition is valid **only within South Africa**. All participants must be residents of South Africa during both the verification process and at the time prizes are awarded.
- All participants selected potential winners are required to present valid identification (South African ID document or passport with a valid residence permit) for verification purposes before any prize is awarded. Failure to produce valid identification will result in immediate disqualification, and a new winner will be selected via a redraw.
